1. Background

Advanced textile materials are a thriving sub-sector in the textile and clothing ecosystem based on high added value and differentiation as unique selling proposition. Innovation in this field is key in the resilience building of the EU textile sector and its competitiveness, particularly in VUCA environments such as COVID-19 pandemic. Two major trends to increase the innovation ecosystem in the advanced textile sector are the update of digitalization and green innovations to address climate change and improve the sustainability of the sector. However, there is a lack of knowledge by textile SMEs in digital tools beyond traditional CRM and ERP. In addition, while sustainability is raising in the textile sector, many companies are still far from exploiting tools and principles such as eco-design.

Therefore, a holistic approach fostering the digital and green transition is needed to boost innovation in the sector through knowledge transfer and co-creation between academia and the industrial sector. Clusters will bring together the triple helix of innovation along with industry. The ERASMUS+ ADDTEX (full title: Advancing industrial digital and green innovations in the advanced textile industry through innovation in learning and training) project main objective is to facilitate the flow and co-creation of knowledge between higher education (HEI) and vocational education and training (VET), research, public sector and business sector within the advanced textile materials sector to foster new, innovative and multidisciplinary approaches to teaching and learning. In parallel, the project aims to stimulate a sense of initiative and entrepreneurial attitudes, mindsets and skills in learners, educational staff and other workers, in line with the Green Deal and Entrepreneurship Competence Framework. ADDTEX will also improve the quality and relevance of skills developed and certified through education and training systems. The project will also reinforce the clusters in each region, supporting education and training of advanced textile materials companies through linkages with HEIs and VETs. The duration of ADDTEX project is 36 months (July 2022 to June 2025).

The activities to be performed and the corresponding expected results of the project are grouped in seven work packages as follows:

Work Package 1: Project management and coordination

Work Package 2: Preparation and gap analysis

Work Package 3: Training development: curricula, training modules and educational resources

Work Package 4: Testing of training and mobility

Work Package 5: Upskilling textile industry through ADDTEX hubs



In order to ensure an objective observation and evaluation of the project progress, quality of deliverables and activities, and impact on the target groups against the project's objectives and planning, an External Quality Committee (EQC) will be set up. It will consist of two persons that will be independent of the project's partners. Their duty will be to gather the necessary data in order to produce two external evaluation reports (M15 & M30) and a follow up report (M36). These reports will be revised and agreed by the task leader (CRETHIDEV) and the rest of the partners.

Duties of the evaluators:

The use of independent tools (e.g. review of documents, questionnaires, personal interviews) for the collection of data to assess the implementation of the project and its deliverables

The evaluation and verification on the quality of the project, the achievement of milestones and objectives, and the results of each Work Package of the project, based on the information provided by the Project Quality Manager, the Project Coordinator, and the partnership

The evaluation of the activities and outcomes of the project for their relevance, efficiency, effectiveness, and impact

Any other contribution to the project that derives from the Quality Assurance and Evaluation Plan and its possible future amendments or specific requests made by the EACEA (Education, Audiovisual and Cultural Agency).

The close cooperation with the 2nd evaluator for the joint production of the required deliverables.

Obligations of the evaluators

To ensure the security of stored data.

To give the necessary feedback to CRETHIDEV, especially on issues that need urgent corrective actions

To treat confidentially all data referring to the project and collected during the evaluation process as well as the produced reports

To participate in two transnational project meetings online or face-to-face if possible

To meet the deadlines as set out in this call
